Master's Level Courses Taught

Advanced Internship in Counseling

This is a synchronous online course for students in the School Counseling Post-Master's Certificate program. Students participate in delivering counseling services in a field setting and receive supervision of their work in weekly seminars. A minimum of 20 hours per week in field placement is required. Course instruction is delivered online using Moodle, Wimba & Centra classroom technologies.

Gender Issues in Counseling

This course involves an exploration of gender as a primary identity and social construct. Emphasis on gender dynamics in courseling, client empowerment and preventive approaches.

Guidance and Group Counseling

The Master's level course covers both a theoretical and experiential understanding of group work – including group purpose, development, dynamics, and group counseling methods. Students practice group planning and group leadership skills in both small and large (classroom) groups.

Human Development for Counseling Professionals

This course introduces the graduate student to human development across the lifespan with a focus on normal and atypical development, developmental transitions, the socio-economic context of development and wellness at each stage of development. This course provides counseling students with a foundation from which to conceptualize and apply developmental theory and research.

Internship in Clinical Mental Health Counseling

Students engage in a 600-hour internship experience in an agency counseling setting under supervision of qualified professionals. Employment of broad repertoire of primary and secondary prevention approaches to individual and group techniques, workshop leadership skills, consultation techniques and advocacy methods. Students participate in weekly meetings with faculty and on-site supervisors.

Internship in School Counseling

Students engage in a 600-hour internship in a school setting under the supervision of qualified professionals. Students perform a variety of activities expected of school counselors. Students participate in weekly meetings with faculty and on-site supervisors.

Practicum in Counseling

This course offers students an opportunity to integrate their didactic training with professional experience. The instructor will provide an atmosphere that will allow students to apply textbook knowledge to practical experiences, develop an understanding of the dynamics of the counseling process, and begin to develop an understanding of how their counseling style affects clients with whom they work. The primary goal of the practicum experience is to assist each student in his or her development of a personally accepted and professionally effective style of counseling. In addition, students will become familiar with a variety of professional activities other than direct service work.

Strategies for Clinical Assessment in Counseling

Exploration of meaning and importance of assessment in the counseling process. The utilization of counseling assessments based on legal and ethical guidelines and cultural considerations. Identify, interpret, and explain assessments in clinical, college and school counseling settings.

Techniques in Counseling

In this course students work towards mastery of counseling skills, review relevant theories, and prepare for Practicum. Students will practice counseling skills in class and spend their out of class lab hours practicing skills in partnering schools. Students will do some limited videotaping of counseling sessions and receive feedback on tapes from Counselor Education doctoral students taking their supervision theory class.

Undergraduate Courses Taught

Helping Relationships

This undergraduate level course teaches fundamental helping skills for human services professionals such as relationship building, reflective skills, basic assessment, and goal setting. Human service professionals in training will gain a foundational understanding of the ways in which they might relate to and learn from clients' worldview. Students will practice these paraprofessional counseling skills during class. In addition, students begin the process of providing and receiving feedback.

Introduction to Human Services

This asynchronous, online, undergraduate course introduces students to the historical development of the human service profession and service delivery models. Topics include the philosophy, values, concepts, language, problems and broad scope of human services, as well as exposure to various agencies and their policies.
